Projects in Process:

- Mill Marginalia Online <millmarginalia.org> I am the Founder, Principal Investigator, and co-Editor of this Digital Humanities initiative, which aspires to digitize and render fully searchable the approximately 50,000 handwritten marks and annotations in the John Stuart Mill Library. Preserved as a special collection at Somerville College, Oxford, this archive is comprised of roughly 1700 books from Mill's personal library at his home in Blackheath, London. The project aims to serve as a venue for peer-reviewed scholarship on the collection, in the form of critical introductions to select volumes with significant marginalia. The project has been featured in *The Guardian*, *BBC Online*, *The Conversation*, Newstalk, Daily Nous, Poets and Writers, and Artwave.
- Sociology in Verse: The Science of Society in Victorian Women's Poetry. That the intellectual pretentions and explanatory potential of the fledgling discipline of sociology caught the attention of Victorian novelists, among them Charles Dickens and George Eliot, has received periodic scholarly attention since the nineteenth century. However, sociology's effect on and presence in Victorian poetry remains underexamined, with Victorian women poets' role in this interdisciplinary conversation even less well understood. Sociology in Verse considers poetry from Elizabeth Barrett Browning, Eliot, Harriet Martineau, August Webster, and others in light of sociological theories of the nineteenth through the twenty-first centuries in order to return these women poets to the socio-literary conversation in which they were always already incisive participants.
